**OFFICE ORDER**

The undersigned is pleased to approve the Advanced Studies Research Board (ASRB) and Graduate Committees to streamline and standardize the review process of research conducted at the institute. This measure aims to enhance the quality, accountability, and oversight of research conducted within the institution, ensuring compliance with institutional and ethical standards.

Approval from the ASRB or the relevant Graduate Committee will be mandatory before submission of the proposal to the Institutional Review & Ethical Board (IREB) for an ethical approval certificate.

The following procedural framework shall be adopted with immediate effect:

**1. Research Proposal Submission (See the algorithm annexed)**

- The faculty, registrars, and demonstrators/lecturers of MTI-HMC/KGMC, and postgraduate scholars of nursing, physiotherapy, and other allied health sciences who want to conduct their research in MTI-HMC/KGMC and its affiliate institutes shall submit their research proposals to the Advanced Studies Research Board (ASRB).
- Trainee Medical Officers (TMOs), House Officers, Undergraduate Students of KGMC and other medical colleges, and Undergraduate Scholars from Allied Health Sciences who want to conduct their research in MTI-HMC/KGMC and its affiliate institutes, shall submit their research proposals to the respective Graduate Committee, depending on the subject area of their proposal.

**2. Mode of Submission:**

- All research proposals must be submitted online through the official website of the Research Deanery (<http://rdkgmc.com>). No hard copies or direct submissions will be entertained.

Research scholars are advised to visit the website of the Research Deanery for the TORs of ASRB and GCs for further details. The website also features comprehensive guidance on the submission process and has all the relevant documents available for downloading.




